Meeting decided:

1. Baltic Enduro Regulations 2017

Change paragraph 5.7. to: In Baltic Championship competitions, if the application for participation is submitted in advance, riders pay FMNR participation fee 60 euro, but on the competition day -70 euro. In national championship competitions, participation fee is decided by FMNR.

Remove text in 8.9.: In that case special tests on the second day are allowed already in the first lap.

Change paragraph 33.6 to: All special tests are with time control. Before the competition start on the first day, competition jury decides which of the special tests on the first lap should be introductory only and may not be timed.

Accept proposed changes in Baltic and Latvian Enduro Regulations 2017.

Guidance for organisers - Hobby class ride the same number of laps as championship classes.

There should be one Baltic Championship competition in each country. Lithuania may decide to organise their competition in Latvia or Estonia (i.e. use a Latvian or Estonian event as a Lithuanian event).

2. Baltic Enduro Sprint Regulations 2017

Paragraph 1.5.: Remove Enduro Street Rally class.

Paragraph 1.5.: Introduce Vintage (Retro) class. Technical requirements will be from FIME Technical Regulations.

Change paragraph 5.7. to: If the application for participation is submitted in advance, riders pay FMNR participation fee 35 euro, but on the competition day -45 euro.

New section 12: Introduce club team cup competition according to the rules of Enduro. Vintage class earns team points with coefficient 0.5.

New paragraph 32.5: All special tests are with time control. Before the competition start, competition jury must decide which of the special tests on the first lap should be introductory only and may not be timed.

Accept proposed changes in Baltic and Latvian Enduro Sprint Regulations 2017.

There should be one Baltic Enduro Sprint competition in each country. Lithuania may decide to organize their competition in Latvia or Estonia (i.e. use a Latvian or Estonian event as a Lithuanian event).

3. Baltic Cross Country Regulations 2017

Remove the status of Baltic and Latvian Championship from Cross Country, i.e. all classes participate in Baltic and Latvian Cup competitions.

Change the first sentence of paragraph 2.8 to: If the application for participation is submitted in advance, riders pay FMNR participation fee 35 euro, but on the competition day -45 euro.

Accept proposed changes in Baltic and Latvian Cross Country Cup Regulations 2017.

There should be one Baltic Cross Country Cup competition in each country. Lithuania may decide to organize their competition in Latvia or Estonia (i.e. use a Latvian or Estonian event as a Lithuanian event).

4. Baltic Enduro, Cross Country and Enduro Sprint competition schedule for 2017

Accept the agreed changes to Baltic Enduro competition schedule for 2017. Distribute to Baltic Enduro commissions for review before publishing.

5. Baltic Results for 2017

LaMSF Enduro Commission will collect, collate and publish Baltic championship and cup results throughout the season of 2017. EMF and LMSF will cover the cost of this activity to LaMSF in the amount around EUR 150 each.
