FMN-Delegates according to the Art. 50.6 Of the FIME Sporting Code. Closing date for entries of FMN Delegates is 15 Days before the Meeting

The meeting will be organized in conformity with the FIME Sporting Code, the FIME&FIM Enduro, the E & R Commission Regulations, the general rules of the (FMNR), where applicable, and this Supplementary Regulations which have been duly examined and approved by the (FMNR).

6. STARTING NUMBERS:

Starting order by classes will be determinate during the 1st Jury meeting on 21st of July See Art 2.3 of FIM Europe European cross country cup regulations.

The organizer must provide the riders with race numbers at administration. Riders must ensure they have the correct color number plates for their class.

Starting order for race is depend on order of technical inspection.

7. ADMINISTRATIVE AND TECHNICAL INSPECTIONS:

In according with FIM Europe European Cross Country Cup regulations Art. 2.4 At administrative inspection the rider must submit his FIM Europe or National Riders Licence, confirmitation of entry fee payment, filled entry form and starting permission from FMNs.

8. OFFICIALS MEETINGS:

The First meeting will be held on 21st of July, 2017 at 21.30

Subsequent Jury meetings will be at times decided by the referee and these times will be displayed on the Jury room door.

9.OPENING CEREMONY:

Will be held on 22.07.2017 at 11.30 on start place.

10. START PROCEDURE:

It is allowed to enter start zone only for riders and marshalls. Riders one by one (after technical inspections) take their start line positions, which cannot be changed.

Start signal is given with engines switched off and with at least 20 seconds interval between start lines:

- -Ready 15 seconds start shot
- -in case of false start (a rider moves from the start line before the start signal), the rider is stopped by a black flag and the riders number on a plate for 3 minutes the first 3 laps.

11. FUEL:

In according with FIM specifications.

12. COURSE:

The time for classes: Junior, Senior, Veteran will be 2 hours (120 min) - starting time 13.00 The time for classes: Woman, Quad will be 1.5 hour (90 min) - starting time 16.00

Course lap length 14 km

13. PIT STOP:

- -A specially marked pit stop shall be located at the side of the course.
- -Refueling is to be performed only in pit stop during the race and only with the engine stopped.
- -Passing through pit stop without stopping and without switching off the engine is forbidden.
- -During refueling, oil change, machine repairs or cleaning a repair mat of an appropriate size and quality must be used.
- -During the competition, <u>ONE</u> mechanic or team representative (easily recognizable) is allowed in the pit stop, in order to provide the necessary technical assistance to riders.

14. INSURANCE:

By endorsing the application form for entry, the FNM of the rider certifies that the rider is insured in according with the FIM Europe requirements.

The organizer has contacted third party insurance in according with Art. 110.1 of the FIM Europe Sporting Code. This insurance includes a guarantee of the minimum amount as stipulated by the FIM Europe Management Council. The Insurance comes in effect 2 days before the first practice and ends after Prize giving ceremony of the meeting. The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incident.

15. PROTEST AND APPEALS:

FIM Europe European Cross Country Cup regulations Art. 3.16

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the FIM Europe, may ask for redress for the consequences of that decision.

Protest must be lodged according to the FIM Europe Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of 130,- € or equivalent amount in local currency, returnable if the protest is justified.

Protests against results must be presented to the Referee within 30 minutes following the publishing of the results.

An appeal can be made to the FIM Europe Disciplinary Commission against a decision of the International Jury.

16. PRICE-GIVING CEREMONY:

Venue of the prize-giving ceremony: starting/paddock area at 18.00, July 22nd.

Riders who qualify for prizes are invited to attend the prize-giving ceremony.

If invited attendance to the prize giving ceremony or press conference is compulsory.

17. INTERPRETATION OF THE SUPPLEMENTARY REGULATIONS:

The interpretation of those regulations and the S.R. is the responsibility of the Referee, who is also empowered to deal with any matter not provided therein.

18. MISCELLANEOUS:

The maximum fee for Transponders rent is 100.-€, the fee has to be returned after the transponder is received back.
